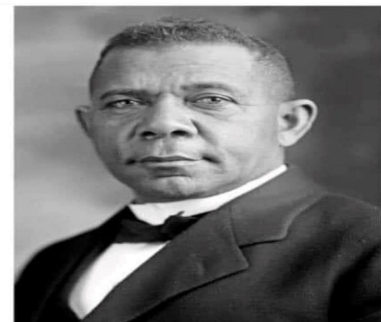

President's Message – April —2024

Dear Members and Fellow Patriots

We are now in the season of elections. This year is especially wrought with lies, deception, voter fraud, and maybe the most heinous of all, “lawfare”. But rather than focusing on the negative aspects of an election season, I invite you to focus on the positive side.

SPEAKER FOR MARCH WAS DARCIA STEBBENS:



Darcia Stebbens, also known as Miss Information, was the speaker at our March 26 luncheon. We know she's full of real, perfect information. She is a CPA in tax season, but she loves any opportunity to talk with people about how we are all fed up with (s)elected officials forcing unwanted programs on us and not listening to us. Darcia said she got started because she saw patterns that didn't make sense when covid hit in 2020, which shut down the world, and affected election processes.

Darcia said the truth about election corruption is coming out. She talked about some of the ways we know this is happening. The movie 2,000 Mules shows us the trafficking of ballots, like there's trafficking of people. It's all related.

The movie, 'Selection Code', is about Gold Star mother, Tina Peters, who was the County Clerk Recorder for Mesa County, Colorado for the 2020 election. Her county used Dominion machines. Tina Peters took a complete copy of ballot images and data from the dominion server right after the election. Then, Dominion came to her offices to do a software update. After their update, she made copies again. They were different. Files had been written over. Files had been deleted. So there was no way she could ever go back and say that these were the numbers for November 2020. These are the people who voted, and these are the ballot images, because it had been changed. Tina Peters exposed some things that people did not want exposed. She has sustained many personal attacks because of it. She's been arrested. She's been jailed. She's been placed on house arrest, all because something wasn't right about an election that she was in charge of, so she documented it.

She presented her data at Mike Lindell's Cyber Security Symposium in 2021. At the symposium, and for thousands of hours since, hackers, cyber ninjas and other experts have extensively studied the before and after data she collected. People like Jeff O'Donnel, The Lone Raccoon, or the Maga Raccoon, from Florida, used material derived from this to do 3 different reports on Mesa County, Colorado. The documentation that Tina Peters derived has been added to the Kari Lake v Adrian Fontes Superior Court case. That case has to do with the problematic November 2022 election in Maricopa County, Arizona.

In Michigan, there was suspicious registration activity ahead of the November 2020 election. A County Clerk in Muskegon alerted police to 8,000 to 10,000 new registrations that came into her office right before the election. A man was arrested who was connected to it. Then there were extensive investigations across Michigan, and over 100,000 registrations were found that were put in by a limited number of people. The FBI took over the investigation, and we have not heard about it since. These improper registration numbers were more than enough to overcome the number of votes that supposedly were for Biden in his "win" over Trump.

Darcia gave us more fun facts. 100% of the people on registered voter lists are sent a vote-by-mail ballot. Many registered voters receive multiple ballots. The son of the Riverside County sheriff received 5. Voter rolls are actually controlled by third party agencies. Eric is the name of one company and it controls the voter rolls of 22 states.

The counting of the ballots is ultimately done with Dominion Machines and software. These are digital files, and with digital files, information can be manipulated. The machines are connected to the internet and so the information is not secure. The information is being sent out internationally, then being sent back. There is evidence but it has not been allowed to be presented. There were no evidentiary hearings. There was no discovery. The Fox News Dominion suit was not allowed to go to discovery. They settled.

This is not a partisan issue. In 2016, Democrats cried that the machines could be hacked. In 2020, it was the Republicans.

She talked about how, if you are a United States citizen and you are overseas, you can request a ballot online, and you can even fax your ballot in. That is not secure. Our county has about 700 military and civilian voters overseas.

Darcia said in the 2020 elections and beyond, in San Luis Obispo County and elsewhere in the country, statistically impossible patterns occurred. Some counties had more than 100% voter turnout, or 95% turnout, etc. That's unheard of! Sometimes every single precinct in an area had the exact same suspicious pattern for a candidate(s).

Darcia talked about voting. We need to get to where we have one day elections, voting in person with paper ballots, at a precinct, with voter I.D. That is the most secure way to vote. You don't have to show them your vote-by-mail ballot. A precinct worker will call to make sure you haven't already voted. Then you get a precinct ballot, not a provisional ballot. Don't let any precinct or election chaos keep you from voting in person on election day. Darcia saw a meme the other day that said, "Don't let Trump cheat. Require voter I.Ds. and paper ballots." We agree!

The ballots need to be counted at the precincts. Even with just 4 people counting at each precinct, we could have verified counts, verified ballots in 12 hours. If there are 8 people counting, we could have results in 6 hours. It would cost \$37,500 county wide to pay people \$25.00 an hour to count.

Half of the counties in California are vote center counties. That means kiosks are placed throughout the county. Voters vote on a computer screen. The vote gets counted electronically, then and there. We do not want that. The further you remove the person from the vote and the vote from the counting, the more can happen.

Darcia talked about her court case, In 2022, Darcia called for recounts in the June 2022 4th district supervisorial race, and in the November 2022 2nd district supervisorial race. \$48,000 was paid for this. We had to halt the recounts when we started running out of funds. That was the county's goal. But Darcia said we received very worthwhile information during the recount. When the county clerk charged Darcia another \$7,000 without any invoices, Darcia knew not to pay it. For almost a year Darcia was in court dealing with the case. At one point, she represented herself in superior court. Happily, Darcia won! And the county owes her money!

Darcia went on to talk about the Bruce Gibson Recall. Gibson said on the capitol steps in Sacramento that 100% of our county was in favor of supporting ACA1. He told Californians that San Luis Obispo County lost out on \$25 million dollars because the people didn't pass a 1% sales tax. He said the 66 2/3% required for voter approval is too high a threshold. It would have passed if we had a constitutional amendment lowering it to 55%. We the People see it differently. San Luis Obispo County taxpayers saved \$25 million dollars! There are many reasons to recall Gibson, but his behavior on the capitol steps was the last straw. It was time to send a very clear message that he wasn't representing us accurately and thus the Recall Bruce Gibson Campaign began.

Darcia's call to action was for as many who can to help get signatures on the Recall petition. Come to HQ and make phone calls to Republican voters, or take petitions to people who request it. We only have 4 more weeks to get enough signatures to get it on the next ballot. It doesn't have to be controversial. This petition stage just gets it on the ballot so people can have a choice to recall Bruce Gibson or not. Lots of people in the county want Gibson to be recalled, but it has to be our district that does it!

Darcia reminded us that throughout human history, God has used imperfect people, like herself, for his purpose. Darcia wanted us to realize that we have the same abilities she has. She told herself, "If not me then who?" We can ask ourselves the same question. We don't have to think someone is more qualified to do it. It really is fun to get involved in the process.

2024 Caring For America

In the months of April and May, the ARWF will be supporting and blessing Kyndal Gottfried a second grader that attends Monterey Road Elementary School and lives in Atascadero. Kyndal has been battling Medulloblastoma for three years, and she and her mother have been flying to Georgia for her clinical trials for the past year. Her mother, Raquel, is a single mother and Atascadero native who is manager at the Atascadero In-N-Out. She graduated from Atascadero High School in 2005.

Kyndal's cancer journey began with treatment in 2021 at the Children's Hospital in Houston. After a year of treatment, they were ecstatic with the news of her remission. Unfortunately, a few months later, her cancer returned. After Kyndal was diagnosed again, she began treatment at the Children's Hospital of Los Angeles.

When the treatment was deemed unsuccessful, Raquel cast a wide net to find a clinical trial that would work for Kyndal's specific cancer. That is where they found a clinical trial in Augusta, Georgia. They have organized two fundraisers and spread the word via newspapers and KSBY news. They feel incredibly grateful for the outpouring of love and support both emotionally and financially from this community, however the travel costs have been more costly than expected.

At the April and May meetings, the Caring for America Committee will be collecting donations for Kyndal and her mother to help ease some of the travel expenses for her treatments in Georgia. Let's bless this family with our support and love.

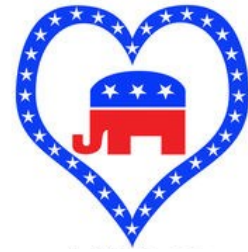

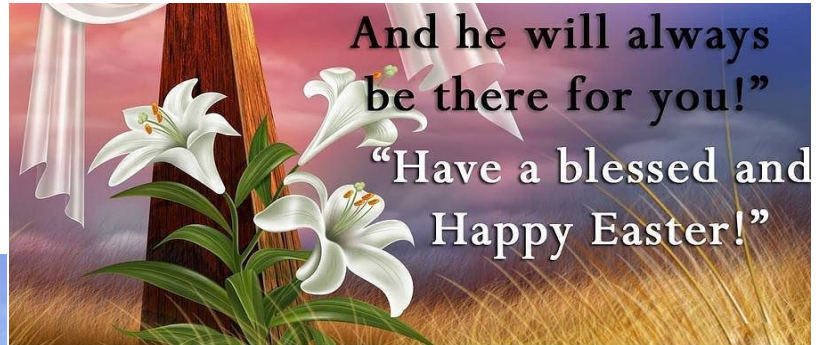


